# Your Business Credit Card(s) will no longer work from 11 May 2021.

Hello,

We wrote to you in May last year to let you know you could continue to use your TSB Business Banking Credit Cards until further notice.

I'm now writing to tell you that we are discontinuing all TSB Business Banking Credit Cards from **11 May 2021**. I'm sorry for any inconvenience this may cause and assure you we will work with you to minimise any impact on your business.

## What is happening and why?

We've decided to discontinue our Business Credit Cards because they don't provide the right level of service for our business customers. You can continue to use your card(s) until 11 May 2021, but all new purchases (including recurring payments) and cash withdrawals will stop from 11 May 2021.

You'll continue to receive monthly statements until any outstanding balance is paid in full. We recommend that you settle the outstanding balance by the end of May or June 2021 as per your monthly statement due date.

If you need support as a result of our decision, such as working capital funding, please contact us and we can discuss other options that may be suitable for you (subject to status and eligibility checks). Call us on 0345 835 3858 and we'll be happy to help you. Lines are open from 8am to 6pm Monday to Friday, 9am to 2pm on Saturdays.

## What if I don't normally pay off my balance each month?

As long as you pay the minimum payment you will continue to receive statements until the balance is fully paid. If you have any difficulties in paying the minimum amount, please get in touch with us on 0345 835 3858.

## Does this affect my other accounts with TSB?

No, we're just discontinuing our Business Banking Credit Cards. The rest of our business banking products are unaffected.
